With said Seventy Thousand Dollars (\$70,000) to come from the Town Buildings Maintenance Capital Reserve. This article is non-lapsing until completion of the project.

There was some discussion and also recommendation to correct the spelling errors (installation of sump pumps).

ARTICLE 7:

To see if the Town will vote to raise and appropriate Twenty Thousand Dollars (\$20,000) to repair the exterior of Town Hall including pillar repair and painting AND painting the exterior Library windows. With said Twenty Thousand Dollars (\$20,000) to come from the Town Buildings Maintenance Capital Reserve. This article is non-lapsing until completion of the project.

ARTICLE 16:

To see if the Town will vote to establish a revolving fund pursuant to RSA 31:95-h, for the purpose of establishing a Police Special Details account, and to raise and appropriate the sum of One Dollar (\$1.00) to be deposited into the fund. All revenues received from the Police Special Details will be deposited into the fund and the money in the fund will be allowed to accumulate from year to year. These funds shall be held in a Special Revenue/Revolving account and the Town Treasurer shall have custody of all monies in the fund and shall pay out the same only upon order of the Select Board who will serve as agents to expend. Such funds may be expended only for the purpose of wages and benefits related to special details and/or police vehicles, police vehicle maintenance and police vehicle equipment replacement.
