CALL TO ORDER: Chris Raymond called the meeting to order at 4:30PM

SELECT BOARD'S BUSINESS:

- 1. **Letter from property owner-**Map 3 Lot 10-E. The Town received a letter from the property owners about a drainage concern on Upper Jaffrey Road. Roger gave some history of the road. The Board will have the Town's lawyer draft a response.
- 2. **Accept resignation of Nick Bergeron** Board accepted the resignation letter effective Feb 11, 2022
- 3. **Highway Department monthly update** Roger reported that two retired highway employees were willing to work as needed until the opening left from Nick's resignation can be filled. Normal wear and tear on equipment from winter plowing is occurring and the department is handling minor repairs. One of the older trucks is out being repaired.
- 4. **Cornucopia- 5:00pm via Zoom** Nina McIntire presented a short slide show as she explained the organization's mission. The Board questioned how this organization meets the criteria of "Health and Welfare Services." The response was that Cornucopia fulfills a Health and Wellness factor by teaching children about nutrition and growing food. - 6. Covid-Discussion of CDC recommendations for employees-The Board agreed to implement the CDC guidelines for employees having or exposed to COVID. Employee's wages will be paid with accumulated sick days. If illness extends beyond available benefits, cases will be considered individually.
- 7. Final Review of 2022 Draft Warrant Articles and Budget- Board reviewed and revised the Warrant Articles. Carole made a motion to increase the Budget Committee line by \$100 for additional training; Susan seconded. Roll call vote. Susan, yes. Carole, yes. Chris, no.
