Board of Selectmen's Meeting
Monday, December 16, 2019

Present: Dale Gabel, Walter Snitko, Chris Raymond, Sherry Miller

Selectmen reviewed the correspondence file.

Dale called the meeting to order at 4:00 p.m.

4:00 p.m. Tom Kennedy

Tom reported that the throttle cable stuck on the loader. He had Roger look at it and they needed to purchase a new throttle cable. It is believed that this occurred because of the decrease in the temperature and the cable froze.

Tom had nothing else to report.

4:30 p.m. Jeannine Dunne

Jeannine sent an email stating that she had nothing for the Board so she cancelled her meeting.

4:30 p.m. Tom Vanderbilt and K Vanderbilt

After requesting that the payroll be calculated another way, the Board reviewed the updated payroll information. After discussion the Board agreed to the following changes:

Fire payroll \$23,000

Rescue payroll \$24,000

Fire training payroll \$12,500

Fire training \$4,000 monthly medical training, three to FF I and \$500 for any additional training needed.

Other business –

Broadband update –

Walter gave an update on the status of Broadband. The Board agreed that Sherry and the Broadband Committee should work together to create the warrant article. The Board discussed adding an additional \$1000 to legal. Dale recommended adding \$1000 (\$31,000) this gives a \$5000 cushion for Broadband.

Planning Board update –

Walter reported that the Planning Board is reviewing the ordinance for short term rentals.

Budget Committee update –

Dale reported that the Budget Committee is taking the Selectmen's recommendation regarding the pay study into consideration. They will be discussing it further at their meeting Tuesday, December 17th.

Hundred Nights –

Walter moved to add Hundred Nights to the charitable / nonprofits in the amount of \$500. Chris seconded. Vote 3-0 ⁱⁱ

Dale moved to approve the request to Charter Trust for reimbursement for money spent to fix the mold issue at the Library and to fix the window sills at the PD. Walter seconded. Vote 3-0 ⁱⁱⁱ

Sherry received an email today from the Tax Collector advising that one of the taxpayers that have a payment agreement with the Town has not made a payment since October. Sherry will send a letter.

There being no further business, Walter made a motion to adjourn at 5:23 p.m.
